12 June - Terengganu Inc has launched an Environmental, Social and Governance (ESG) Agenda with a 35% Renewable Energy (RE) Capacity Mix target by 2025, in line with our 2023-2025 Strategic Plan.

The target was announced during the launch of the ESG Affairs 2023 program themed "Embracing Transition Towards a Sustainable Future", which was attended by more than 200 guests.

It is pertinent that the Sustainable Development Goals (SDG) of Terengganu Inc are in line with the State's aspirations and the Islamic concept of Maqasid Syariah, enabling a successful transition.

In the said event, Terengganu Inc successfully inked a Memorandum of Understanding (MoU) on the Feasibility Study to Develop Floating Solar Photovoltaic (FSPV) in Kenyir Power Stations with TNB Power Generation Sdn Bhd (TNB Genco), allowing research towards one of the most extensive floating solar panels in South East Asia.

The 2000-hectare project in Tasik Kenyir will undergo a rigorous research process and is expected to produce 500MW in the area.

The ESG Affairs 2023 highlight of the day was a talk, "ESG & Sustainability as a Business Concept," delivered by Encik Norhisham bin Abd Bahrin, Partner at Azmi & Associate. The discussion provided insights into the rise of sustainability and ESG considerations and approaches.

A forum titled "Advancing ESG Principles and Sustainability in Terengganu" moderated by Encik Norhisham bin Abd Bahrin, featured a panel discussion with esteemed panellists









7 June - The plantation subsidiary of Terengganu Inc Group, Ladang Rakyat Trengganu Sdn Bhd (LRTSB), successfully inaugurated their Biogas Power Plant and Humus Factory at Kilang Sawit Bukit Bandi, Kemaman, marking a significant step towards 'waste to wealth' model.

The Biogas Power Plant was commenced in 2021 and spans over a 2-hectare site with an investment of RM18 million.

Meanwhile, LRTSB's Humus Factory provides cost-effective domestic fertilization using internally sourced palm oil mill waste. The factory can potentially produce 20,000 metric tonnes of fertilizer annually, yielding RM4 million in profit.

13 June - Pangkalan Bekalan Kemaman Sdn Bhd (PBKSB), a subsidiary of EPIC Berhad, has signed contracts with PETRONAS Carigali Sdn Bhd (PCSB) Petroleum and eight other Arrangement Contractors (PACs) to provide supply base facility services at Kemaman Supply Base Terengganu. PBKSB will offer various forms of resources and integrated solutions to PETRONAS and eight other PACs.

14 June - Golden Pharos Berhad (GPB) will sell its downstream timber products overseas in a strategic partnership with Supreme Group, the largest timber company in Selangor.

Through Pesama Timber Corporation Sdn Bhd, a Memorandum of Understanding with Supreme Group's unit Forest Avenue International on the partnership. This will guide Pesama in expanding its market segments, particularly in finger-joint and moulding timber commercialisation

1 June - Chicken Cottage, the cherished fried and grilled chicken chain from the UK, has announced its ambitious plan to significantly expand its footprint across the country.

The brand's vision is to launch 20 new stores over the next two years, cementing its reputation as a leading player in the British fast-food industry. This exciting development follows the successful recent store openings, bringing the total store count to 51 including Orpington.





8 June - TDM concluded its Annual General Meeting for its financial year ended 31 December 2022 with a high commitment to optimising long-term business prospects and building resilience to ensure sustainability of its primary business segments.

Chaired by YBM Seri Bijaya Raja (Datuk Tengku Farok Hussin bin Tengku Abdul Jalil), Chairman of TDM, the resolutions stated in the meeting were approved by the shareholders present.

TDM is optimistic about its capacity to foster long-term growth in the upcoming fiscal year. The key to accomplishing this is emphasising mechanisation and digitalisation.

28 June - Syarikat Air Terengganu Sdn Bhd (SATU) with Pengurusan Air Pahang Berhad (PAIP), held a site visit for the Gebeng Water Supply Project in Kuantan. Under this project, Bukit Sah Water Treatment Plant (WTP) in Kemaman will provide up to 90 Million Litres Per Day (MLD) for industrial use in the Gebeng Industrial Area, situated close to the Pahang-Terengganu border, stimulating industrial activities in the East Coast.





GOLDEN PHAROS BERHAD RECORDS 463 PERCENT INCREASE PBT

20 June - EPIC Berhad concluded its 42nd Annual General Meeting (AGM) chaired by its Chairman, YAB Dato' Seri Dr. Ahmad Samsuri bin Mokhtar who is also the Menteri Besar of Terengganu.

At the AGM, EPIC Berhad announced its audited financial results for the financial year ended 31 December 2022 (FY2022), having recorded a revenue of RM343.1 million, a 17% increase compared to RM292.2 million in the financial year ended 31 December 2021 (FY2021).

23 June - Terengganu Inc and the Terengganu State Tourism Department is pleased to hold the Inauguration Ceremony of Pulau Poh Bridge, Kenyir Lake in conjunction with the Sixty-First Birthday Celebration of His Royal Highness, the Sultan of Terengganu (KDYMM). The Sultan of Terengganu, KDYMM Al-Wathiqu Billah Sultan Mizan Zainal Abidin Ibni Almarhum Sultan Mahmud Al-Muktafi Billah Shah completed the inauguration of the Poh Island Bridge, Lake Kenyir.

The architecture of the Pulau Poh bridge is based on the concept of traditional Terengganu boat decoration with a stork head motif.

It has been built with the concept of fixed cable construction with a capacity of four lanes 133 meters long and has become a crucial link between Pengkalan Gawi and Pulau Poh Marina, Lake Kenyir.

13 June - The Chairman of GPQ Sdn Bhd, YB Dr Haji Mamad bin Puteh has led a productive update visit to the Marang River Road and Bridge Upgrading Project. During this visit, a briefing session on the development of the project was delivered by the JKR and the GPQ-LGBE Joint Venture, which is the contractor appointed to upgrade the Road and Bridge Across the Marang River worth RM338.5 million.
