

8 January - Konsortium Pelabuhan Kemaman Sdn Bhd (KPKSB), a member of EPIC Group, for the first time in the history of its 16 years of operations, handled and discharged a new liquid chemical cargo of sulphuric acid at its Liquid Chemical Berth (LCB) terminal.

The sulphuric acid vessel chartered by Kemaman Bulking Sdn Bhd (KBSB) arrived last year and departed on 2 January 2023 with a shipment of 10,000 metric tonnes (mt). The sulphuric acid was successfully discharged through a 600-metre newly built direct pipeline – a result of over a year of hard work by the team.

29 January - Syarikat Air Terengganu (SATU) Sdn Bhd received a courtesy visit from Syarikat Air Kelantan Sdn Bhd (AKSB). The delegation led by AKSB General Manager Dr. Haji Nazmi bin Ghazali Azmi was welcomed by SATU Chief Executive Officer, Ts. Abdul Karim bin Endut with the SATU team.
