TDM RECORDS 30% YEAR-ON-YEAR EBITDA IMPROVEMENT IN 2QFY2022

29 August - TDM Berhad announced its financial results for the second quarter ended 30 June 2022 (2QFY2022). 2QFY2022 revenue came in at RM159.4 million, increasing by 44% year-on-year (YoY) from the RM111.0 million reported in the corresponding quarter last year. TDM also registered a Profit Before Tax (PBT) of RM4.7 million this quarter, turning around from the Loss Before Tax (LBT) of RM1.4 million in 2QFY2021.

At the same time, Earnings Before Interest, Taxes, Depreciation, and Amortisation (EBITDA) jumped 30% YoY from RM22.7 million to RM29.6 million over the same period.
